From 2010 to 2014, he successively served as the executive director and director of Beijing Dacheng (Shanghai) Law Office. After the merger of Dacheng and Dentons, an international law firm, in 2015, Mr. Zou successively held the positions of global director of Dacheng, director of China Region, deputy director of China Region Management Committee, deputy director of China Region Dispute Resolution Professional Committee,

director of China Region Financial Dispute Resolution Research Centre, and expert consultant of China Region Real Estate and Energy Professional Committee, and devoted himself to building Dacheng into a truly international law firm. In 2022, Mr. Zou was awarded the honor of "Meritorious Service" on the occasion of the 30th anniversary of Dacheng.
