Introduction: Jaya Prakash graduated from the University of Singapore with the degree of Bachelor of Laws (Honours). He was admitted as an Advocate and Solicitor of the Supreme Court of Singapore in January 1975.

Fellowship: Mr Prakash was made a Fellow of the Singapore Institute of Arbitrators in 2000 and a Fellow of the Chartered Institute of Arbitrators in 2000.

Arbitration: In recent years, Mr Prakash has been sought as an arbitrator in commercial, transnational and maritime disputes. He is familiar with Singapore, English and Malaysian laws and has particular expertise in commercial and maritime law. Mr Prakash has drafted and issued more than 100 arbitration awards.
