### Mediation Style

I generally facilitate the mediation process by appraising parties of not just the time, costs and expenses involved if they go to Court or arbitration, but also the risks involved regarding the merits of their respective positions. This often requires a deep dive into the papers with the assistance of the counsel involved. It is rare for a party to have a "sure-win" case, as every case has its weaknesses, and parties invariably do themselves a favour when they explore mediation to resolve their dispute amicably.
