She had mediated several cases referred by Singapore Mediation Centre and the Law Society Mediation Scheme pertaining to commercial disputes as well as high-conflict disputes in divorce proceedings and has successfully brought about settlement between parties in most of these cases. She had also assisted as volunteer mediator for cases assigned by Centre for Dispute Resolution (State Courts) and the Family Dispute Resolution Registry (Family Justice Courts). Currently, most of Engelin's cases are referred to her as part of her private mediation practice.
