Woon Chooi started her career in the Legal Service as the Assistant Registrar of Trade Marks and Patents hearing IP disputes. She was then transferred to assume another role as the Assistant Official Assignee and Public Trustee, administering bankruptcy and companies winding up cases.		

Woon Chooi left the Legal Service to join the Intellectual Property practice group of Drew & Napier. She then joined the Corporate and IP practice group of Helen Yeo & Partners (now known as Dentons Rodyk & Davidson).

Woon Chooi was one of very few lawyers who successfully managed a litigation practice, as well as a corporate commercial solicitor's practice. She had represented clients in high stake civil intellectual property (IP) cases, as well as criminal IP cases. One notable court case was when she defended a generics pharmaceutical company in one of the first "second medical use" lawsuits in Singapore, commenced by Novartis in relation to a patented medication. Woon Chooi managed to achieve a successful outcome which enabled the generics company to supply the Singapore market with a cost-effective alternative medication.

The highlights of Woon Chooi's corporate and commercial law practice includes advising:

- Jetstar on the Valueair-Jetstar merger;
- StarHub in negotiations with Singtel in relation to the Network Lease Agreement for StarHub to carry out Cross Carriage requirements;
- Saudi Arabia's Reza Group in its purchase of McDonalds franchise rights for Singapore and Malaysia; and
- Rancak Selera Sdn Bhd (Malaysia's sovereign wealth fund company) on its franchise rights upon its acquisition of a 100% stake in Burger King Singapore Pte Ltd.

Woon Chooi was one of the pioneer lawyers in the franchising industry in Singapore. In the 1990s, she was instrumental in setting up the Franchising and Licensing Association (Singapore) or "FLA", an association of franchising businesses. For many years Woon Chooi was a judge of the FLA's prestigious Franchise Awards.

Woon Chooi was one of the lead senior partners in Dentons Rodyk & Davidson providing advice on personal data protection, privacy and cyber-security issues.

After 30 years of legal practice, she stepped down as a partner of Dentons Rodyk & Davidson to pursue her personal interests. Woon Chooi became a licensed realtor and an actress, giving her valuable insights into the real estate and entertainment industry.

Woon Chooi continues to provide strategic advice in her capacity as a consultant with Orion IP (a boutique IP firm), and Ares Consultancy (a consultancy providing commercial advice).
