Mediation Style

<u>Understanding-based integrative mediation – Omni-partiality</u>

My role as a Mediator is to help the parties resolve their conflicting interests. Different types of disputes and each party's preference affect my methodology. There is no single mediation method that works for everyone. Integrating a facilitative, evaluative, and transformative approach is art. Among others, understanding-based mediation is of paramount importance. Without understanding the industry background, the underlying commercial reasons, and each party's emotions, it is impossible to resolve a dispute through mediation. I have witnessed many cases where parties could not reach an agreement without any rational reason but solely due to an emotional confrontation. We tend to believe that humans act based on logical analysis, but history proves that this is an illusion. A human mediator can't be neutral and impartial in mediation but can be Omni-partial. That's the way I meditate.

Mediation Experience

I successfully resolved multiple disputes between the subnational government of Korea and the concessionaire regarding PPP infrastructure projects (road). Mediation and negotiation with the government require patience. Because the government is involved in politics, numerous stakeholders are involved in government disputes. For a settlement to be successful, a mediator must understand the local politics and bureaucracy.

I successfully mediated a dispute between a U.K. investment fund manager and a Korean institutional investor regarding the divestment of an investment asset and the fund's dissolution.

I successfully mediated a dispute between multinational shareholders of a container terminal in Busan, Korea. The investors were from the construction, financial (senior/junior), strategic, and operational sectors.

I successfully mediated a shareholder dispute between an individual founder (seller and minority) and a financial investor (purchaser and majority). Due to conflicting interests, various disputes arose from the earn-out clause in the share purchase agreement. Moreover, an individual founder has a deep emotional attachment to their company. A challenging case to resolve the conflict.

I successfully resolved a dispute between a Korean conglomerate with a majority share and an international investor with a minority share. The minority shareholder holds negative control, but the conglomerate has a greater influence within its territory. In order to resolve this kind of multicultural dispute, it is imperative that the mediator have a thorough understanding of the Korean conglomerate's culture.

I represented an international investor in a shareholder dispute with a Korean conglomerate. The dispute concerned a deadlock situation caused by equal shareholding between the investor and the conglomerate regarding the investor's divestment. In order to achieve a better-negotiating position, the mediator must accurately evaluate the best alternative to a negotiated agreement. Due to the successful negotiation, the shareholders ultimately settled and withdrew their ICC arbitration.

I successfully represented a Korean bank in a French conciliation procedure between a large French container shipping line and a Korean government-backed bank regarding a French shipping line's credit risk during the financial crisis.
